I choose to rise each time I fall.




## **Our Vision**

The Purpose of Next Step is to provide encouragement, hope and peer support programming to men who demonstrate commitment to their own rehabilitation during their time of incarceration and upon release.

Next Step program participants needing safe housing and a supportive environment upon their release can apply for candidacy to Future Hope's Quixote House Intentional Community Residential Program.

## **QUIXOTE HOUSE**

(since 2008)

The Purpose of Quixote House is two-fold: 1) to provide safe, affordable, drug and alcohol- free transitional housing to men in their transition from prison to halfway house to community; 2) to provide an **Intentional Community** Residential Program that offers accompaniment, structure, guidance, encouragement, and community-living peer support to men re-

entering mainstream

society.

#### REPORT FROM BOARD CHAIR

This AGM concludes the 2024-25 year per the charity's calendar - one in which a lot was done in order to keep up with improvements to operations and the board itself. We welcomed new members to the board that had longstanding experience with Future Hope and have reaped rewards because of it. We continue to operate with realistic budgets as we have done for the past several years - budgets that do not include 'projected' revenues from sources that were not secured. Because of this and thanks to past and present board members, we have been able to identify proper duties and hours for persons able to help in the role of house manager, and implement the required part-time position to help with Next Step duties.

Things are still in progress, but the reports I have received are quite positive and operations at the houses and meetings are running well. Apart from the staff and residents, I can say that much of this is due to the fine work of our committees, from HR ratifying employee needs, to SC and FDC and their efforts to keep funds directed at key requirements and plan for the charity's future. Part of that work continues as we say farewell and all the best to retiring board members such as John Hutton. Formal thanks go to all the staff, volunteers and residents for making things work. We still have basic goals of obtaining multi-year funding, and there is always the long-term goals of expansion into more housing and Nest Step meetings, but such things do not materialize without sustained funding. Luckily, we have multiple sets of hands around to help with that process. As acting head of the HR, SC, and FDC committees, I have the rare opportunity to roll all the AGM reports into one. The minutes from each meeting are well documented, so I shall only highlight a few key points from the year. HR looked after the employee health requirements, evaluations, hiring, and provincial standards for Inspection Services Unit Workplace Safety and Health under the Department of Labour and Immigration.



SC updated our manuals, put together this very day as we have had a call for skill-sharing and training for years - an opportunity for lots of voices in FH to come together. SC will continue to be busy as any transitioning board members will need replacements. No easy task. FDC really shined with events like the craft show and the upcoming dinner. It was not just FDC with a hand in raising money as the comedy night repeated itself to new highs. FDC is better focused in my opinion and we have been extremely successful in getting grants and funds from nearly a dozen organizations. Our list of donors and thank-yous is getting quite long. Luckily, Zeffy continues to operate well for us in conjunction with our accounting team of D&E. I can easily note that we would not be operating as efficiently without the work of the accountants who follow up with all transactions and deal with mountains of paperwork that must be done to ensure compliance. The task now is to keep up the work without overextending ourselves - that goes for everyone in the organization. We shall continue with the business of ratification at this AGM and soon enough will be preparing for another. Best thanks to all those involved for performing fine duties.
